The Housing & Planning Act is unfair, destructive and unworkable. It would attack existing council and housing association renters and leaseholders, and push millions more into private renting without rights or rent controls.

Already 70% of people are living with a housing

crisis. High rents, insecurity and rising evictions, overcrowding, waiting lists and homelessness – all will get worse if the Housing & Planning Act is implemented.

The outline Act was passed in May – but crucial regulations have not yet passed: it can't be enforced until 2017 or later. Criticism of 'Pay to Stay' is mounting and housing minister Gavin Barwell is backing away from Starter Homes targets.

As cracks widen, opposition is growing to resist and defeat this Act. You can help defeat the Government and win the homes we really need.

COUNCIL HOUSING FINANCE SABOTAGED

Council housing is being sabotaged. After a 60 per cent cut in housing investment in 2010, ministers in 2016 announced a one per cent rent cut. Tenants welcome lower rents, but this measure cynically undermines the 'selffinancing' financial settlement.

Councils took on unjustified and inflated debt as part of the settlement in 2012, freeing them to run a local 30-year business plan. The rent cut for 2016-20, plus increased Right to Buy discounts and the threat to force sale of higher-value

council homes, are already wrecking local financial plans.

Reopening the settlement, and writing off inflated and unjustified debt, would allow councils to build a new generation of first class, energy-efficient council housing.

The Housing Act threatens to:

- Drive up rents with a pay to stay tenant 'tax'
- Sell off and cut new council and housing association homes for rent
- Spread insecurity by ending lifetime tenancies
- Give more public land to expensive private development
- Speed up demolition of estates
