Has your council decided on stock retention?

98 authorities have already decided to keep their homes after consulting tenants. But many will struggle to carry out all the improvements that tenants need.

Tenants, councillors and trade unions from stock retaining authorities need to be part of the campaign to win the 'Fourth Option' and a level playing field to secure the long term future for council housing.

Are you in an ALMO?

The National Federation of ALMOs now propose transferring the ALMO companies into the private sector. Despite promises that ALMOs were set up with the specific remit to meet the Decent Homes standard they are working to take the two-stage privatisation process further. Discuss with other tenants, trade unionists and councillors from ALMO authorities how to campaign for the homes to revert back to the council once the improvements have been completed.
